Narrative:	on this date, i was one man meeting with BCW to remove children from a home at Once seeing how the people in this residence were going to behave, I attempted to ask for another car to respond. I made this attempt for approximately 5 minutes, with no luck inside or outside of the home. The situation soon became physical. During the incident, I was never able to come over the air and ask for another car. Most of my attempts resulted in the long loud beep. Some of the other attempts resulted in no sound at all. I was finally able to get a squad number over the air, after nearly 10 minutes of asking for another car. Help arrived red lights and sirens, with officers thinking I was asking for an assist. Not only was my safety put at risk		

because of this radio failing, but as was the safety of every officer who w	as
responding in emergency fashion.

## Comments

This email is in response to the radio trouble report that you submitted regarding the welfare check at on Monday, April 20, 2010 at about 4:00 p.m. The CAD showed that you were dispatched on Day Shift at 3:13 p.m. It is my understanding from a conversation with Sgt. Gawin that you told the dispatcher, at that time, that you were one person until your partner got out of court. Per the CAD you went on scene at 3:42 p.m. after which Early Shift handled the call. I checked the recording of the radio traffic regarding the call and the following is a chronological time line and transmissions for the incident:
