## Simple instructions on signing and/or circulating nomination papers

### Signing

1. Signers must be eligible to vote in Milwaukee County (but no need to be a registered voter).
2. Sign, fully address (street, city, zip) and check mark if you live in a city, village, or town.
3. Signatures must be dated between 12/1/2011 and 12/31/2011 and appear on the form in date order.

### Circulating

1. Circulators must witness each signature. Nomination papers cannot be left to be signed unattended.
2. You may sign the nomination paper and also sign as the circulator.
3. Sign, address, and date the "circulator" section at the bottom of the form (do not date it until you are ready to return it). **Contact CRG with ANY questions or concerns at ANY time (contact info below).**
