There still is confusion as to what is happening here.

To use an analogy:

- Ford builds cars. The basic structure of the vehicle (body, engine, wheels, etc) would be similar to your portable radios.
- Ford adds items/ programs to make the car perform basic functions. The transmission is told how to shift. The light switch is made to turn on headlights. The engine is programmed to minimize emissions. ETC. These are BASIC functions of ALL cars. Without these additions the car would not function. It is this BASIC information that was lacking from your portable radios. This is the BASE FILE. Base file tells the radio what frequencies to use, how far to allow the volume to turn on up, what menus to be present, how the radio connects to the radio system, etc. This base file is what was missing from the radios. All radios get the same base file, plus a very small part of unique information (serial number, IP, etc). This base file will be built and installed in your radios by Wednesday.
- Ford can't control how you USE their cars. Suppose you want to drive to Minneapolis. You need to determine the route. You may need maps. You plan for the drive. These are all items to make the car USABLE. They are unique to each car, and maybe unique to each use of the car. You don't need to have a car to plan a trip to Minneapolis. You can research the route, obtain maps, etc, all without the car present. This work makes the car USEFUL, not functional. PERSONALITY is the radio equivalent to this. How you are going to use the radio has no bearing on actually having the radio in hand. You can plan how to use the radio at any time. PERSONALITY loads from the radio system to each radio whenever you turn on that radio. PERSONALITY is NOT programmed into the radio. Therefore, PERSONALITY can be built months previous, ready for use whenever the radios are to be put in service. PERSONALITY can take time to construct, due to

numerous interrelationships. Therefore PERSONALITY is a planned event. You don't make changes "just in time".

• If the PERSONALITY layout you sent on Tuesday (01/12/2009) is what you want, please confirm ASAP. I will start rebuild of PERSONALITY upon your OK.
