As you may have heard, Madison will convene a special council meeting on Thursday to extend collective bargaining agreements so that all our unions are on the same footing, with a contract through 2012. We are racing against the clock so that our extensions will go into effect before the bill becomes law. To make matters worse, if the state law goes into effect first, the amendments to the agreements will make them null and void under the provisions of the new law. If that happens, all our employees will be subject to the benefit cuts immediately, instead of at the end of the current contract.

Are you aware of other municipalities who are racing to alter their CBAs before the bill goes into effect? If we can convince the Secretary of State that there are others out there like Madison, we may be able to get a little extra time before the bill is published and officially becomes law.
